## Terms and Conditions – Booking Contract

Please note that your booking is not confirmed until we issue a Booking Confirmation to you following receipt of:

- (i) The agreed deposit
- (ii) Our Venue Hire Terms and Conditions

## **VENUE HIRE TERMS AND CONDITIONS**

- All bookings are subject to these Terms and Conditions to the exclusion of all others and may only be varied in writing signed by the Company Director
- ii. You undertake to comply (and to ensure that your guests comply) with all applicable laws, licenses, regulations and policies in force at the host venue. Fire Exits and routes must not be obstructed.
- iii. An Event is only confirmed when we issue a booking confirmation following a receipt of the agreed (non-refundable) deposit and a signed copy of these terms and conditions. Until this time your booking is provisional, and we may cancel it, without liability by sending you a written notice of cancellation.
- iv. All Prices are subject to VAT at the current rate. A discretionary 10% service charge is applicable on food & drinks pre orders and bar tabs.
- v. Where a Minimum spend has been agreed in the Event Booking Contract, you shall be liable for the full minimum spend, should your event run short of the spend the difference payment must be completed at the end of the event.
- vi. For full Venue Hire (closing the pub from the public) there is a £100 non-refundable or redeemable fee of £100 this will be taken from your deposit.
- vii. For full Venue Hire of the Garden (closing the Garden from the public) there is a £100 non-refundable or redeemable fee of £100 this will be taken from your deposit.

- viii. Your £400 deposit to secure your booking is not refundable at any point. Your deposit is only redeemable against your food and drinks bill once the agreed minimum spend is met.
- ix. Under no circumstance may food be brought into the Venue, apart from a celebration cake.
- x. Under no circumstance may be verage be brought onto the Venue.
- xi. Any Damage to, or theft of, property at the Venue caused by the client or guests will be charged to the client at full replacement cost.
- xii. We will be under no liability whatsoever for any loss, damage or injury to your property, or the property of your guests or any other persons for whom you are responsible.
- xiii. Last drinks orders at our bar is served at 11.45pm, you will not be able to be served after this time excluding water. The Venue shuts at 12am, please ensure all carriages are booked prior your event to avoid delay leaving the premises after closure due to taxi/ uber limitations in the area
- xiv. Security is required at 21<sup>st</sup> and 18<sup>th</sup> parties. They will also be required at any parties over 100 people. The security payment is the responsibility of the client, the cost is £24 per hour + VAT. They will be required to be at the function throughout the entire private hire.
- xv. Identification will be required at all functions. Anyone without identification to prove they are over the age of 18 will not be served any alcohol.
- xvi. At 18<sup>th</sup> and 21<sup>st</sup> Parties anyone who has given identification to prove they are over 18 will be provided with a stamp or token ton show staff members when ordering alcohol. Staff will still have the right to ask and check identification.
- xvii. We reserve the right to refuse or remove admission to the Venue any visitor or guest deemed in the reasonable opinion of our staff or security personnel to be intoxicated untruly, threatening, violent, dangerous, under the minimum age.
- xviii. When having a DJ at your private function their contact details must be given to the Venue due to noise restrictions at the venue. The noise levels will be monitored throughout the function and music will be turned off if it

is continuously played above the required level. Please note that music must be turned down to a reasonable level at 11pm and off at 11:55pm
